Applies to all plants >10 MW, which do not fall under art. 19 and 73 para. 4 Energy Law (GO/SC plants).

Company-internal transactions (i.e. transactions between the accounts of companies that form legal unit) are free of charge. On the other hand, transactions between legal entities, which e.g. belong to a group, are subject to fees.

## **General conditions**

The fees will be invoiced if the total costs exceed the invoice amount of CHF 50.- per party per year; invoices are issued at least once a year.

The executing body charges a workload-related fee for the operating costs associated with the guarantee of origin system. The most recent version of this list of fees shall apply.

The cancellation fee will not be introduced until the guarantees of origin system 2.0 (SHKN 2.0) goes live. Until that time, no fees will be charged for cancellation.

Further fees will be charged for additional effort that is not part of the service within the meaning of the «Agreement Governing Use of the Swiss Guarantee of Origin System» based on time and material expenditure (e.g. individual training).
